What is IATA Connect?

IATA Connect is a digital space for safety collaboration for operators, auditors, regulators, aviation professionals, and IATA.


It will host the IOSA Registry, IOSA Audit Report Repository, and program documentation. Each IOSA operator will have its own profile, and confidential information is shared under the airline's control.

Additionally, it integrates the IATA Safety Issue Hub to share and monitor risks, obtain guidance material, and exchange risk mitigation strategies through expanded IATA Safety Connect capabilities for networking and collaboration.

Besides a dynamic newsfeed containing important program announcements and updates, individual users will also be able to participate in discussion groups.

We will be sending out further communication on the on-boarding process in the coming weeks.








Join our Q&A session!

IOSA Auditor Trainings

So far in 2024, 4 auditor training courses were delivered successfully - 3 IOSA Auditor Training courses and 1 Risk-Based IOSA Conversion training course.

Well-prepared and equipped auditors to uphold the highest standards in aviation safety remain our priority.

IOSA Standards Manual (ISM)

ISM Edition 17 will be published in the month of July and become effective 1 January 2025. The manual will be made available on the new platform IATA Connect.





IOSA Facts & Figures

Since the beginning of 2024, our program has conducted 11 Risk-Based IOSA and 50 Conventional IOSA audits. Furthermore, so far in 2024, 13 Risk-Based IOSA and 50 Conventional IOSA audits have been closed. As a result, 17 airlines were added to the Registry for the first time, while 46 airlines successfully renewed their registration.

The IOSA Registry now proudly hosts 431 airlines from over 100 countries across 5 different regions.
